Client Information Notes

According to relevant regulations, we have to ensure that you have provided us with updated customer identification information ("CID"). The relevant CID to be collected are set out as follows:-

♦ For an individual client, his orher:

- □ Full name as shown on his or her identity document;
- Identity document's issuing country or jurisdiction;
- Identity document type (order of priority: (1) HKID card;
 - (2) national identification document; (3) passport); and
- Identity document number on the identity document

♦ For a corporate client, its:

- □ Full name as shown on its identity document;
- Identity document's issuing country or jurisdiction;
- Identity document type (order of priority: (1) LEI registration document; (2) certificate of incorporation; (3) business registration certificate; (4) other equivalent documents); and
- Identity document number on its identity document.

• For a client that is a trust:

The CID of the trustee, which should be the same as that of a corporate or individual client as set out above;

However, in the case of a trust which is an investment fund (i.e. collective investment schemes), the CID of the asset management company or the individual fund, as appropriate, which has opened a trading account with the Relevant Regulated Intermediary.

♦ For clients of a joint account:

The CID for all clients (in line with the above proposed requirements, depending on the nature of the client) named for a joint account should be provided under the same BCAN assigned tothat account.
